

ALLIANCE FRANÇAISE DE SYDNEY – 2019 SCHOOL COMPETITION

TERMS & CONDITIONS

1. Only school students enrolled in Years 5-12 in New South Wales in the calendar year of the Competition are eligible to participate.
2. Each participant may submit no more than one entry for any of the following: “Option Ciné”, “Option Photo”, and “Option Chanson”.
3. All entrants must complete their paid registration and entries must be received by the advertised closing date and time. Registration is completed through the Alliance Française de Sydney website (<https://www.afsydney.com.au/french-courses/school-competitions/>) or by telephone with the Alliance Française de Sydney. Submissions are to be shared via www.wetransfer.com to the email address school-activities@afsydney.com.au
4. Registration will be taken to mean acceptance of these Terms and Conditions. By submitting an entry to the competition, each entrant grants the Alliance Française de Sydney the right to use their name and contact details for the sole purpose of identifying them as the author of their entry and/or winner of this competition.
5. Late, illegible, incomplete, defaced or corrupt entries will not be accepted. No responsibility can be accepted for lost entries and proof of transmission will not be accepted as proof of receipt.
6. All submissions must be the original work of the individual or group submitting them. Each individual whose image is featured in a competition entry must have given consent for the use of their image in connection with this competition and in accordance with these Terms and Conditions. Where an individual whose image is featured in a competition entry is less than 18 years, the entrant confirms that the parent or guardian of that individual has given the relevant consent.
7. Submissions must show no inappropriate or dangerous behaviour, or otherwise be obscene, defamatory, distasteful, offensive or in breach of any applicable law or regulation, or in breach of any confidentiality obligations owed by them to third parties.
8. If the Alliance Française de Sydney has any reason to believe an entry is not an original work of the entrant or otherwise breaches these Terms and Conditions, then the Alliance Française de Sydney may not consider it and may disqualify it.
9. Copyright in all images submitted for this competition remains with the respective entrants. However, in consideration of their providing the competition, each entrant grants a worldwide, irrevocable, perpetual licence to the Alliance Française de Sydney to use, republish, edit and/or modify/feature any or all of the submitted images in any media including their publications, their websites and/or in any promotional material connected to this competition.
10. A panel selected by the Alliance Française de Sydney will judge all valid entries, and the winners will be selected in October 2019. The panel selected will include members of the Board of the Alliance Française de Sydney and its teachers.
11. It is a condition of entry that all rules are accepted as final and that the competitor agrees to abide by these rules. The decision of the judges is final and no correspondence will be entered into.
